

2. The manufacturers/ Stockiest/ Authorised dealers/ Govt. approved firms can participate in the tender process for any of the items or all items of the inputs.
3. The intending bidder will have to submit up to date income-tax return and should have up to date GST Return.
4. Preference may be given to the supplier/ agency that can provide all required inputs or as per the decision of the tender opening committee.
5. The tender will be valid for one year from the date of finalisation.
6. The bidder or their authorised representatives shall remain present at the time of opening of the tender.
7. The interested Agencies / Firms may take the tender documents from the office of the Chief District Veterinary officer Gajapati, Paralakhemundi during the office hours in any working day or can download the document from Gajapati District web portal.(<http://gajapati.nic.in>).
