01. The engagement shall remain valid for one year of the vacancies in the rank of base level posts are filled up by regular recruitment whichever is earlier and can be extended for subsequent period with spell of one year each subject to satisfactory performance up to a total period of four years not beyond the age of 65 years.
02. The selection procedure will be governed by the procedure and Rules laid down in G A Department Resolution No 23750/Gen dt 27.08.2014.
03. Re-employment officers shall be governed by the provisions of Government Servant's Conduct Rules, 1957 and shall be liable to be proceeded against for their misconduct, omissions and commissions as per the provisions under Odisha Pension Rule 1992.
04. Monthly remuneration of engaged officers shall be fixed as per the Finance Department Office Memorandum No 24533/F dt 29.09.2022.
05. Officers who have retired from Government Service on attaining the age of superannuation and not beyond the age of 65 (Sixty Five) years having good service records and physically fit shall be eligible to be considered for engagement. In any case the candidate should have minimum of one year of time left while computing 65 years of age to be eligible for engagement as on the last date of application.
06. Officers against whom Departmental proceedings / Criminal Cases / Vigilance cases are contemplated / pending or who have been penalized for misconduct during the period of preceding five years will not be eligible for consideration.
07. The performance of the officers is to be reviewed periodically and documented at least once in a quarter
08. On review of their performance, if their performance is found unsatisfactory, their engagement will be terminated without giving any reason thereof within the contract period and the decision of the appointing authority i.e CDM&PHO Gajapati by giving one month notice to the concerned engaged employee.
