It has been decided to procure Fibre Square Net of approved quality by inviting sealed tenders. The Dealer/Manufacturer/ Individuals or Persons expressing interest shall procure the tender application Form from the O/o the Divisional Forest Officer, Paralakhemundi Forest Division, on any working day from **10:00 AM to 05:00 PM from 12.06.2020 to 22.06.2020**. The Cost of the Tender paper of **Rs. 200/-** only shall be deposited in shape of Demand Draft drawn in favour of the Divisional Forest Officer, Paralakhemundi Forest Division payable at Paralakhemundi while submitting the tender.

The tenderer has to furnish all required documents & rate of the material, Taxes separately in the application form. The tenderer has to submit the technical bid and financial bid in two separate closed covers.

Eligibility: -

1. The invitation to participate in the Tender Document is open to Original Fibre Square net producers.
2. The Tenderer must not have been banned or black listed by any Government organization.

Terms & Conditions:-

1. The Tenderer has to attach EMD of Rs. 30000/- (Rupees thirty thousand) Only in shape of Demand Draft purchased from any Nationalize Bank in favour of Divisional Forest Officer, Paralakhemundi Forest Division payable at Paralakhemundi along with the tender; otherwise their bid shall not be qualified for the tender. The EMD shall be refunded to unsuccessful bidders.
2. The successful tenderer shall furnish a security deposit @5% of the total bid amount duly pledged in favour of the Divisional Forest Officer, Paralakhemundi Forest Division in shape of Demand draft only drawn on any nationalized bank payable at Paralakhemundi. This Security deposit of the successful tenderer shall be retained at Paralakhemundi Forest Division & shall be returned after completion of the delivery of the materials. If the tenderer fails to deliver the required quantity of the Fibre Square Net of agreed quality in time as per agreement, then the security deposit shall be forfeited to Govt.
3. The tenderer or his authorized representative shall produce a sample packet of their materials before the tender selection committee.
4. The Technical bid only shall be opened on **25.06.2020**. The Tender Selection Committee may inspect the Fibre Square Net production site mentioned by the bidder for on the site evaluation and sample collection. The date of opening of Financial Bid shall be communicated through the Notice Board of Division Office.
5. The Fibre Square Net production unit should be within Odisha State.
6. The Tenderer shall execute an agreement with the Divisional Forest Officer, Paralakhemundi Forest Division in line with the terms and condition laid out in the tender document.
7. The Tenderer shall deliver the Fibre Square Net at the approved sites within the period as per agreement.
8. The material should be delivered at different Range Head Quarters of Paralakhemundi Division and proper weighing will be made in **presence of the Forest Range Officer In-charge of the Range & taking counter signature on Challan Copy**.
9. A Sample of the Fibre Square Net shall be sent to any authorized laboratory for analysis. The Laboratory analysis report should match the specification furnished by the Tenderer in the original tender application form and the sample collected by the Tender Selection Committee. Failing to comply the Laboratory approval, the tenderer shall be responsible for non-payment of material cost & the material shall not be accepted.
10. The price quote of materials furnished in the bid document shall be inclusive of Taxes transportation and other handling charges for delivery at different range head quarters of Paralakhemuni division.
11. All payments to the Tenderer including EMD and Security Deposit shall be adjusted after completion of delivery of approved quality Fibre Square Net.
12. The rate of successful bidder will be valid up to 31.03.2021 or next call/ tender call.
13. All the dispute shall be subjected to the jurisdiction of civil courts situated at Paralakhemundi Town.
14. The payment will be made after receipt of funds from the competent authority.
15. At the time of payment of bills in the income TAX and other Taxes liable to deducted if any shall be deducted at source as per Govt. rules and guidelines as may be prevailing at the time of payment.
16. All documents and Original tender paper with Form No. A and B should be signed by the Tenderer.
