OFFICE ORDER

Whereas the Government of Odisha, in exercise of powers conferred under Section 2,3 and 4 of the Epidemic Diseases Act, 1897, has framed the Odisha COVID-19 Regulations, 2020 for prevention and containment of Corona Virus Disease, 2019 (COVID-19);

And whereas the Government of Odisha, vide Revenue & DM (Disaster Management) Department Notification No.1706/R&DM(DM) Dated 13.03.2020, has declared COVID-19 as a 'Disaster' under Section 2(d) of the Disaster Management Act, 2005 for the state of Odisha.

Now whereas, the number of COVID positive cases proliferating in unexpected pace within a time span of one month is really a matter of concern.

Now, therefore, in exercising the power conferred under the Disaster Management Act, 2005 & Epidemic Diseases Act, 1897, I **Sri Anupam Saha, IAS, Collector & District Magistrate** being the Empowered Officer do hereby **impose shutdown in Gosani Block, Gumma Block, Ranipentha GP of Kashinagar Block and Municipal jurisdiction of Paralakhemundi of Gajapati District from 28.06.2020 to 30.06.2020** in the interest of public health and to contain the spread of COVID-19.

During the shutdown

1. All economic activities shall remain closed except for medical activities related to medical establishment including hospital, medical shop etc., and delivery of milk.
2. The emergency services and transport services communicated by State Government vide order No.3057/R&DM(DM) dated-01.06.2020 only shall be permitted.
3. The special medical teams will ensure screening of all residents and reporting of symptomatic cases to RRTs (Rapid Response Teams).
4. RRTs will screen localities from where COVID cases have been detected daily for symptom and will refer them for testing and isolation alongwith symptomatic cases referred to them by health team engaged in door to door screening.
5. No public (visitors) shall be allowed in any public offices.

Keeping in view of the shutdown, market will be open from 5.00AM to 9.00PM only on 27.06.2020 (Saturday) to enable the public to meet their needs during the shutdown.

The guidelines relating to shutdown shall be strictly enforced. Any person violating shutdown measures shall be liable for prosecution as per relevant provisions of the Disaster Management Act, 2005 and the COVID-19 regulations, 2020 and legal action u/s 188 of the IPC and other legal provisions as applicable.
