2. The last date of receipt of sealed tender papers is **24.11.2021 by Registered Post / Speed post or courier service**
3. The tenders will be opened on dt. **25.11.2021 at 11.00 AM.** at CDM&PHO Office, Gajapati in the presence of the tenderer or their authorised representative observing all COVID -19 safety protocol
4. The cost of the tender papers must be deposited in shape of Demand Draft issued by any Nationalised Bank in favour of CDM&PHO Gajapati, Payable at Paralakhemundi.
5. The following documents should be furnished along with the tender papers failing which the tender is liable for rejection.
  - a) EMD duly pledged in favour of CDM&PHO Gajapati in shape Bank TDR deposited receipt of Schedule bank ,KVP, NSC , Post office time deposit .
  - b) Self Attested copy of the contractor registration certificate (CDMS Copy) .
  - c) Self Attested copy of GST Registration Certificate, Form GSTR-3B [ See rule 61(5)] September or September on wards

5 calendar month

- d) An affidavit in support of the authenticity of the documents.
  - e) SC/ST Contractor desires of availing preference should submit an affidavit in support of caste certificate and attested copy of recent caste certificate otherwise their tender will be liable for rejection.
  - f) DD of tender paper cost .
  - g) Bid cover must be super scribe with name of the work tender for.
6. The cost of Tender Paper with all requisite documents is compulsory and non-refundable..
  7. The bidders who have earlier participated in the tender process of this CDM&PHO, Gajapati but backed out or not responded for drawl of agreement during the financial year 2015-16 to , 2020-21 .causing abnormal delay in finalization of tenders are not allowed to participate in this tender.
  8. Further those bidders who are awarded work by this office earlier causing abnormal delay in completion of awarded work , If any such bidder participates in this tender his case will be summarily rejected.
  9. Contractors whose agreements have been rescinded and work order cancelled due to their inefficiency in completing the awarded projects of this CDM&PHO, Gajapati office from 01.04.2012, they are not allowed to participate in this tender process.
  10. The EMD amount is to be forfeited if the tenderer backs out from the offer of acceptance of tender by the competent authority.
  11. The successful tenderer will have to submit the detailed work programme for timely completion of the work.
  12. The contractors whose performance is not satisfactory or inefficiency in completing the awarded work of this office is not allowed participating in this tender process.
  13. In case of shortfall of any required document, the tender paper is liable for rejection.
  14. However, the Department will not be responsible for any lapses or Postal delay in receving of Documents.
  15. Performance security shall be deposited by the tenderer as per codal provisions .
