2. The Hire Charge should not exceed to Rs. 20,000/- (excluding POL charges) P.M as per Govt. Guidelines.
3. The vehicle should be LMV (6+1 seated) preferably Bolero. It should be equal to or within the life span of 2 years as on 31.03.2019 i.e date of purchase from the authorized Dealer should be on or after 31.03.2017.
4. The vehicle along with the driver will remain present at the office of the Special Officer, LSDA, Serango throughout the month.
5. If the vehicle will not be available as and when required for any default on the part of the owner the hire charges will be deducted proportionately and the agreement may be terminated.
