Sealed Tenders are invited from interested reputed Travels Agencies/Tour Operators or private individuals for providing one number at DRDA, Gajapati of Non-AC Diesel driven vehicles having sitting capacity not more than ten including driver, which shall conform to the Terms and conditions (Annexure-I) for official use in DRDA, Gajapati on monthly rent basis :

The vehicle must be in Road Worthy condition, shall not be more then 3 years old from the date of initial registrations and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.

- 1) The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 2) The Driver should be well behaved, gentle and obedient in nature.
- 3) A sum of Rs 5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the Project Director, DRDA, Gajapati payable at SBI, Paralakhemundi and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
- 4) The monthly hire charges of Rs 16000/-(Rupees sixteen thousand will be paid to the successful bidder per month (excluding POL charges).
- 5) The vehicle must achieve a fuel efficiency of 14 Kms per liter incase of Indica.
- 6) The details of the make and year of manufacture of the vehicle, registration no., mileage (Kms covered per liter) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation / Tender (Annexure-II).
- 7) The Quotation completed in all respect should reach the undersigned on or before 20.09.2019 by 2:00 PM and shall be opened on the same day at 4:00 p.m in presence of bidders or their authorized representatives.





**TERMS & CONDITIONS FOR HIRING OF VEHICLES**

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

1. The hired vehicles, during period of contract, shall have all necessary valid MV documents such as:- valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. and D.L. of the driver available all the times.
2. The Office hiring the vehicle shall not be responsible for any damage/ loss caused to hired vehicles or loss of life/ injury made to any person or damage to any property on account of use of hired vehicle in any manner whatsoever.
3. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating oil of engine, gear box & differential coolant, tyres & tubes, battery etc., will be borne by the bidder.
4. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
5. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/ bidder.
6. In case the vehicle does not report regularly on time, the authority will be at liberty to reject the agreement and may engage vehicle from the other source.
7. The vehicles shall report for duty for minimum of 25 days in a month.
8. Monthly hire charges as per actual and as per Govt. norms (Finance Department Letter No.27037/F, dated 08.10.2015) will be paid in every succeeding month on verification of log book maintained by the driver, as far as possible within fifteen days of the submission of bills by the owner and No advance payment will be made.
9. The hire charges to be paid after deduction of Service Tax or any other Tax as applicable by law on monthly basis is final but does not include cost of diesel, which is to be paid separately by DRDA.
10. If the services are found to be unsatisfactory, the hirer shall give one month notice and terminate the agreement.
11. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to give one month notice before such withdrawal of service and termination of agreement.
12. If the bidder violates any of the terms of contract, the bidder shall forfeit the entire amount of security deposit.
13. The Authority reserves the rights to cancel or reject any or all the quotations without assigning any reasons thereof.
