Tender Call Notice

Bid Reference No. – CDM & PHO (Gajapati) – 2018-19 – DC – 01

Sealed tenders are invited from registered manufacturers/ authorized distributors/ suppliers for supply of Drugs & Consumables for Gajapati District. The intended suppliers, manufacturer, Distributors are required to quote the rates for the following items. The tenders reaching after due date shall summarily be rejected. The specification and names of the items of the manufacturing company should be mentioned in the tender. The tender paper cost of Rs.200.00 (Non-refundable) by way of separate Demand Draft drawn in favour **CENTRAL WARE HOUSE, GAJAPATI** payable at SBI Main Branch, Paralakhemundi from any Nationalised /Scheduled Bank. The intended suppliers should also furnish the latest **GST Certificate, GST monthly return for last applicable month Certificate, PAN Card, valid Drug License Certificate and authorization** from competent authority. The Companies should be of **GMP/WHO GMP & ISO certified companies**, failing which their tender shall be rejected. Bidders who have been blacklisted either by the Tender inviting authority or by any district/state Govt. or Central Govt. organization for the quoted item is not eligible to participate in the tender during the period of blacklisting. **Affidavit** of the same to be submitted stating that the firm has **neither been black listed nor any criminal cases** pending against them. The drugs are to be supplied with door delivery within 10days of receipt of the orders, if not the order shall remain cancelled automatically. The supply is to be made in less number of batches (less than 3) with one phase and should arrive at the warehouse with remaining shelf life of at least 5/6th of the stipulated total shelf life from the date of manufacturing of that product. The last date of submission of tender is **Dt.12.07.2018 by 5 PM** through **Reg. Post /Speed Post or Courier** services only along with all the relevant documents. The Bidders may download the Tender Documents directly from the **WEBSITE** available at www.gajapati.nic.in within **Dt.12.07.2018**. The bidders are to submit their tenders in separate sealed covered envelope for technical bid and financial bid by subscribing "Technical Bid" in cover "A" and Financial Bid in cover "B" and both covers should be put in third cover which should be subscribed as "Tender for Supply of Drugs & Consumables". The Bidders should specifically super scribe, **"DOWNLOADED FROM THE WEBSITE"** on the top left corner of the outer envelope containing Bid reference number. The tenders received shall be opened at **11 AM on Dt.13.07.2018** in the chamber of CDM & PHO, Gajapati and the said firms are requested to attend on the said date and time or send their representative.
