

QUOTATION/TENDER CALL NOTICE FOR HIRING OF VEHICLE FOR MVU OF GAJAPATI DISTRICT

Sealed quotations are invited from the Travel agencies/Tour operators or Private Individuals for hiring of vehicles preferably TUV300/ BOLERO/TATA SUMO GOLD/Ertiga on monthly rent basis for the year 2020-21 for MOBILE VETERINARY UNIT of 02 (Two) Blocks of Gajapati District (i.e. Rayagada, and Kasinagar). Interested Travel Agencies/ individuals may submit their offers mentioning DOL Consumptions in Kms/ Litre and hiring charge per month including GST specifying the Block opted for. One vehicle can be opted for maximum 2 blocks in preference and in such case separate bids may be submitted with only one security deposit per vehicle.

The following guidelines may please be adhered to.

1. The vehicles quoted **must be within 3 years old** from the date of registration.
2. A **security deposit of Rs.5000/- is mandatory**, shall be deposited by the intending bidders in shape of account payee SBI Bank Draft drawn in favour of the Chief District Veterinary Officer, Paralakhemundi, payable at SBI Main Branch Paralakhemundi and submitting along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders. Persons already have submitted the security deposit in the previous tender and who have not returned back the amount, may specify the details of the draft already submitted and need not deposit a security deposit draft again.
3. The MVU vehicle owners should have valid PAN No & GST Registration.
4. Vehicle should be insured with valid registration number.
5. All repairs/maintenance/payment of all taxes will be borne by the owner with an alternative vehicle for the period of breakdown if any, without compromising the services of MVU.
6. The licensed driver should wear a uniform & badge license, he should be a non-alcoholic and should be available as and when required as per State Motor Vehicle Rules.
7. **Bids will be taken into comparison among the qualified bids opted for same Block.**
8. The owner has to supply DOL for the month/months until re-imburement of the HSD bills.
9. An agreement will be made with the vehicle owner before engagement of vehicle for M.V.U work with details terms & conditions as per MVU guidelines obtainable from this office.
10. The CDVO, Gajapati reserves the right to cancel the process of quotation call / any or all quotations without assigning any reason thereof.

Agencies/ Individuals desirous of giving their vehicle on monthly rental basis with above terms and conditions may submit their offers in the prescribed format addressing to the "**Chief District Veterinary Officer, Gajapati, Paralakhemundi**" in sealed covers super-scribing "**Quotation for hiring of vehicle for MVU-2020-21**" along with the photocopies of the following documents by SPEED POST or by HAND which should be delivered in this office in working hours on or before **Date-22.09.2020 by 5 P.M.** and the quotations will be opened on **23.09.2020 at 10.30 A.M.** in presence of the quotationer /one authorized representative on production of Id proof & authorization letter. There is no bar for opening of the quotations in absence of any or all the quotationers/ representatives as per scheduled time of opening.

- 5) Photo copies of PAN No and Aadhaar card of the owner/proprietor.
