





Criteria for SHG Identification

The following criteria should be followed for SHG identification: -

1. Age Limit of members should be 18- 50 yr.
2. All members must have an active Bank Account.
3. Members must not be a bank loan defaulter.

Specification of Activities/ Training Programme

1. Tasar Silkworm Rearing – 10 SHGs (5from Gumma & 5 from Kashinagar).
2. Value Addition through reeling/Spinning (Silk Yarn Production): -
 - I. No. of candidates for batch – 20 X 5 batches = 100 members
 - II. Age limit – 18-50 years
 - III. Training period for reeling/Spinning activities – 5 months.
 - IV. Monthly remuneration/ Rent to candidates & MCMs, Raw Material/Tools, machines – Entire training cost shall be borne by SANKALP scheme under Ministry of Skill Development.
