The sealed Quotation will be received by speed post or by hand only on or before date 22.05.2023 till 2 P.M. and the Quotation will be opened on dt.23.05.2023 at 10.30 A.M. in presence of bidders or their authorized representatives in the O/o CDVO, Gajapati, Paralakhemundi. The absence of any of the bidders or their representatives will not be a bar to open the quotations received. The quotation received incomplete and after scheduled date and time shall be rejected. Rates should be quoted for each items including GST and other taxes and the items are to be delivered at O/o CDVO, Gajapati, Paralakhemundi. The undersigned reserves right to reject any or all quotations without assigning any reason thereof. All legal disputes if any relating to the quotation are subject to jurisdiction of court of law of Gajapati district.

### PREQUALIFICATION FOR QUOTATION:

1. The participating bidder should be an authorised Dealer/Distributor/Supplier having valid drug licence & GST registration.
2. The participating bidder who has been blacklisted by the State Govt. /Central govt. /any PSU is not eligible to participate in this procurement process through quotation.
3. Agencies/bidders of Odisha state only are allowed for bidding.

### TERMS AND CONDITIONS OF QUOTATION:

1. The quotation should be neatly type written without any correction/overwriting & each page of quotation paper should be numbered.
2. Supply should be made at the O/o-CDVO, Gajapati, Paralakhemundi within 07 days of receiving supply order.
3. The bidder should have a valid drug licence.
4. The bidder should have valid GST registration certificate of Odisha state.
5. The bidder should enclose self-attested copy of PAN, copy of valid drug licence, GST Registration certificate and GST clearance for last quarter and IT Return for last three assessment years.
6. The bidder can submit their quotation for individual or multiple items intend to supply from the list of medicines mentioned below inclusive of all taxes
7. The tax will be charged as per Govt. guideline.
8. The Payment shall be made after delivery of items in proper condition and as per specification through RTGS after submission of bills/vouchers. The bank details of the bidders should be mentioned on the body of bill.
9. Medicines supplied shall not have expiry date less than one year.
10. Valid ISI/CE/US FDA/ WHO GMP/ GMP Certificate of the products from manufacturer end as per the specifications mentioned against each item is necessary.
11. Priority will be given to the reputed firms for purchase of medicines.
12. The rate contract once approved should remain valid for one year from the date of approval.
13. The bidder should give a self-declaration in his office letter pad that he has not been blacklisted by the State Govt. /Central govt. /any PSU.
