

PROCEEDINGS OF SELECTION COMMITTEE MEETING FOR RECRUITMENT OF GROUP D(JUNIOR HELPER POST) OF ASSISTANT DIRECTOR OF SERICULTURE,CHANDRAGIRI HELD ON DATED 10.07.2019

As per the decision taken by the selection committee in the meeting held on dated 25.06.2019, the candidates who have not submitted their 7th standard mark sheet were given another opportunity to submit the same on or before dated 10.07.2019. As such this office has communicated notification vide letter no 500(29) dated 27.06.2019 to all the candidates for submission of the 7th standard mark sheet on or before 10.07.2019.

As per the short listed candidates who have not qualified in the first round due to non submission of required documents published in the proceedings of the meeting held on dated 25.06.2019 in Annexure no II , were not enlisted for today's scrutinization process . Therefore out of total 29 candidates only 24 candidates applications were scrutinized today. Out of these 24 candidates only 8 candidates could submit their mark sheets and the balance 16 no of candidates did not submit their mark sheets.Hence these 16 candidates were disqualified in the scrutinization process of 2nd round .But in this context,since all the 24 candidates could not submit their Marksheets duly signed by the competent authorities within prescribed dateline ,in order to establish fairness and transparency in the recruitment process, the selection committee had decided to provide these 16 nos. of candidates extension of time for another 15 days from today so as to give them an opportunity to submit their Mark sheets on or before 30.07.19 , 5.PM positively without fail in the office of the undersigned for finalization of the recruitment process.Accordingly the committee had recommended the Chairman for issuing fresh notifications to the 16 number of candidates from the office so as to allow them to submit the Marksheets within the due date.

The details of the candidates those were qualified or disqualified in today's meeting is given in Annexure III & IV below .

The meeting was ended with a vote of thanks to the Chairs.
