
Sealed Quotations /Tenders are invited from interested reputed Travel Agencies / Tour Operators or Private individuals for providing 01(One) no. of Non-AC Diesel driven vehicles (**Bolero/ Marshal/ Tata Sumo/ Mahindra Max**) having sitting capacity not more than 10(Ten) including Driver, which shall conform to the Terms and Conditions prescribed by the Government of Odisha (Annexure-II) in O.M. No.27037/F. Dated.08.10.2015 for official use in the office of the Assistant Registrar of Cooperative Societies , Paralakhemundi Circle, Paralakhemundi under Government of Odisha in Cooperation Department on monthly rent basis.

1. The vehicle must be in Road worthy condition, shall not be more than 3 years old from the date of initial Registration & must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contact Carriage Permit, proof of up to date tax payment etc; which is mandatory for plying of vehicle.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle
3. The driver should be well behaved, gentle & obedient in nature.
4. A sum of Rs.5000/-(Rupees Five Thousand) shall be deposited by the intending bidders in shape of Account payee Bank Draft in favour of the **Assistant Registrar of Cooperative Societies, Paralakhemundi Circle, Paralakhemundi** & submit along with the tender paper as security deposit. After completion of the tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charge (**Maximum Rs.20, 000/-P.M.**) may be quoted separately in general bid information (excluding fuel & Lubricant).
6. The vehicle must achieve a fuel efficiency of **12(Twelve)** KMs per liter.
7. The details of the make and year of manufacture of the vehicle, Registration Number, Mileage (Kms covered per liter) and name of the Driver with Driving License No. & period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender (Annexure-III).
8. The quotation completed in all respect should reach the Undersigned on or before 08.08.2019 by 12 Noon & shall be opened on the same day at 2 P.M. in presence of the bidders or their authorized representatives.






