The Candidates who fail to attend the counseling session personally on the above date his /her candidature will be deemed to be cancelled. The authority reserves the right to cancel the engagement order if any certificate is found to be fake. The vacancy will be shown to the candidates in order of merit. However preference will be given to the PH candidates followed by female and male candidates called on merit. Engagement order to the PH candidates selected under PH category will be given after clearance from the Appellate Medical Board. The candidate found place in provisional merit list do not confer any right for engagement as SS (JT Contractual). The place of posting is not a matter of right for any candidate.

Those who have placed in the approved merit list they have to produce the following required documents at the time of counseling:

1. The candidate should bring with them all original certificates along with one set of self attested photocopies in a fly leaf.
2. Two passport size colour self attested photographs.
3. An agreement paper duly typed and filled in on Rs.11/- (non-judicial) stamp paper is to be submitted by the selected applicant during the engagement.(Sample of agreement copy is attached)
4. The candidate is to submit medical fitness certificate a fresh from any Govt. medical officer not below the rank of ADMO as per the prescribed format at the time of receipt of engagement order. (Sample of medical fitness certificate attached)
5. An undertaking to be submitted at the time if issue of engagement order. (Sample copy attached)

AGREEMENT

Between Chief Executive Officer, Zilla Parishad Gajapati District-cum-Collector (herein after called the "First Party" of the one part and Sri/ Smt./ Kumari \_\_\_\_\_ Son/ Daughter/ Wife of Sri \_\_\_\_\_ aged about \_\_\_\_\_ years residing at vill \_\_\_\_\_ Po \_\_\_\_\_ PS \_\_\_\_\_ in the District of \_\_\_\_\_ herein after called "Second Party" of the other part.

And whereas, the Second Party is willing to be engaged as **Sikshya Sahaya/ Junior Teacher (Contractual)** to impart teaching in the Primary/ Upper Primary Schools under School & Mass Education Department. Government of Odisha and to motivate the parent/ Guardians to send their children to schools and will be assigned such other works relating to teaching for the objective of universalization of Primary Education and implementation of Right of Children to Free and Compulsory Education Act, 2009.

NOW THIS AGREEMENT WITNESSED and the parties hereunder hereby agree as follows:

1. That the First Party shall provide engagement to the Second party as **Sikshya Sahayak/ Junior Teacher (Contractual)** in Primary/ Upper Primary Schools for a period commencing on ..... Day month ..... year and ending on ... .. Day ... Month ..... Year.
2. That the Second Party shall submit himself/ herself to the orders of Zilla parishad and of the Officers/ Authorities under whom he/she may from time to time be placed by the First party and shall at all times, obey the rules prescribed and shall discharge whenever required to perform such duties as may be assigned.
3. That the Second Party shall employ himself/herself efficiently and diligently and to the best of his/her ability.
4. That the Second Party shall be paid Rs 7400/- (Rupees- Seven Thousand Four Hundred) only per month as consolidated honorarium.

5. That, the Second Party shall not claim the service benefits as admissible to the State Government employees.
6. That, the Second Party shall not be eligible to get any other allowance and shall not claim any other dues except the honorarium as mentioned in Clause (5) above.
7. That, the Second Party shall not be eligible subject to exigency of Public Service for casual leave of 12 days during an academic year.
8. That, the Second Party shall not be entitled for any other kind of authorised absence beyond authorised leave, if he/she remains absent with permission and he/she does not have any authorised leave at his/her credit, the proportionate amount from/his/her consolidated remuneration shall be deducted.
9. Teaching in the school shall be the main duty of the Second party.(SS), but duties will be assigned by the 1<sup>st</sup> Party in accordance with the RTE Act.
10. The Second Party must ensure minimum level of learning (MLL) for the students as prescribed by the competent Authority (SME Deptt.)
11. The Second Party must ensure at least 90% attendance of the children in respective schools ' in all classes.
12. The Second Party shall reduce the drop out of the children in school below 10%.
13. The Second Party would attend training Programme as may be fixed by Govt. from time to time.
14. The Second party shall abide by the rationalization of teachers policy of Govt. as issued from time to time.
15. That, the Second Party has agreed to serve in the manner as required and perform the duties assigned by the First party and he/she has agreed to be disengaged without any notice on ground of involvement in criminal case/ misconduct/ delinquency/ incapacitation/ unauthorized absence/ poor performance.
16. The engagement shall be cancelled, if any fraudulent testimonial is detected in future.
17. That the engagement order issued is subject to the result of WP(C) No-3471/18, 3681/18, 3682/18, 4297/18, 3677/18, 3679/18 and other cases pending in Hon'ble High Court of Odisha.

IT IS EXPRESSLY STATED AND AGREED that any duties rendered under this agreement by the Second Party shall not in any circumstances whatsoever provide him/her any right to claim for any scale of pay or to be appointed in any service that may exist now or may arise in future in any educational Institutions or in any Government Offices. 
