## 1. ELIGIBILITY AND QUALIFICATIONS OF THE COUNSELLOR:

A candidate, in order to be eligible for the above post, shall –

- i) be a citizen of India;
- ii) a) have a Master's Degree in Social Science preferably in Sociology or Psychology.

b) have a degree in Social Science preferably in Sociology or Psychology and he/she must be above the age of thirty-five, working in the field of social service and welfare activities and engaged in promoting the welfare of Family and Child Care.

# (SI.No.(a) will be preferred ahead of SI.No.(b))

- iii) have minimum experience of three years in family counselling.
- iv) Be able to speak, read and write Odia and must have passed test in Odia equivalent to the M.E. Standard.
- v) be sound health, good physique and free from organic defects or bodily infirmity, and
- vi) have not more than one spouse living.

#### 2. FUNCTIONS OF A COUNSELLOR:

Counsellor entrusted with any petition shall assist and advise the parties regarding the settlement of subject-matter of dispute between the parties or any part thereof. The Counsellor shall also help the parties in arriving at reconciliation.

# 3. FEE OF A COUNSELLOR:

Fee of the Counsellor is Rs.788/- per day of actual work done as per Resolution No.1693/L Dtd.15.02.2019 of Government of Orissa, Law Department, or as prescribed by the Hon'ble High Court of Orissa from time to time.
