Sub: Guidelines for setting up of Biogas plants under GOBARdhan scheme of SBM-G -  
reg.

Madam/ Sir,

With reference to the above-cited subject, I am to inform you that one of the key components under the Swachh Bharat Mission-Grameen Phase II scheme, is the GOBARdhan program under which Biogas plants are to be set up in the rural areas. The biogas plants will convert the cow dung waste generated in the villages into useful resources.

In this regard, the Department after discussions with OREDA, has decided to take up community-level bio-gas plants in the rural areas of the State with incentive support from SBM-G. The following are the modalities and procedures to implement the same:

1. Community Groups and Institutions running Gaushalas in rural areas like Trusts, Milk Unions/ Cooperatives, NGOs, and FPOs having cattle populations shall be eligible to take up Community-level biogas plants.
2. Only those institutions having a minimum of 15 no. of cattle inside a single premise shall be eligible.
3. Standard size of 6 cu.m. community biogas plant costing about Rs. 98,000 can be taken up. (Model, design and estimate for 6 cu.m. Deenabandhu model biogas plant is attached in Annexure 1).
4. Maximum of Rs. 50 lakhs per district is provisioned as per the SBM-G guidelines for taking up community biogas plants. The funding pattern per project will be in the ratio of 70:30 in which 70% of the project cost will be supported as grant from SBM-G



funds while the remaining 30% of the project cost is to be borne by the beneficiary institution.


5. Invitation for applications shall be made through advertisement by the district in any widely circulated Odia daily along with display of notice in District website, office of the Collectors, CDOs, BDOs and GPs for wide dissemination to get maximum applications. A minimum of two months' time shall be given for submitting the application from the date of advertisement in the newspaper. The application format is attached in Annexure 2 and the advertisement format is attached in Annexure 3.
6. The complete applications along with all the relevant documents should reach the office of the CDO, Zilla Parishad on or before the last date as per the advertisement. The application can be submitted through post/ courier/ by hand.
7. The total number of applications received at the end of 2 months will be scrutinized at the district level as per the set eligibility criteria. A committee consisting of CDO, APD Technical, CDVO and BDO(HQ) will examine the proposals and share the eligible list with the respective Blocks for field verification by the Block AEs/JEs/GPTAs.
8. If the applications received are within the upper cap of Rs. 50 lakhs per district (71 applicants) then all the applications meeting the minimum eligibility criteria can be forwarded to the respective BDOs for verification. In case of more applications, priority will be given to community groups/ institutions with larger cattle populations.
9. AE/JE/GPTAs of respective Blocks will physically verify the site, number of cattle and land records submitted by the applicant institutions. Basing on the field verification report and recommendation of AE/JE/GPTA, the eligible applications will be approved at the block level and intimated to the CDO for records. In case there is an existing functional or non-functional bio-gas plant within the premise, the institute shall not be eligible under this scheme. Checklist for AE/ JE/GPTA for physical verification is attached in Annexure 4.
10. On completion of construction of the biogas plant by the beneficiary, the beneficiary shall intimate the same to the BDO in writing based on which, the AE/JE/GPTA will physically verify and certify it. Then one-time payment of maximum 70% of the cost of standard 6 cu.m. biogas plant (maximum Rs. 70,000) as subsidy shall be released to the beneficiary institution through PFMS from block level and the same to be intimated in writing to the beneficiary.
11. The respective beneficiary institutions shall be responsible for the construction, operation, and maintenance of the biogas plant along with the safe management of the bio-slurry. It must be ensured that the bio-slurry from plants is not disposed of in drains.
12. Tentative timeline for implementation of the GOBARdhan scheme:

Field verification and sanctioning of projects	15 days from forwarding the eligible list to block for field verification
Construction by beneficiary institutions	4 months from sanction of the project
Payment to beneficiary	15 days post intimation by the beneficiary

It is therefore requested to finalise the beneficiaries as per the above instructions within the timeline and ensure smooth implementation of the GOBARdhan program in the State.

## **Guiding Principle for Biogas Plants for Community Institutions and Groups**


Biogas plants will facilitate the conversion of cow dung waste generated in the villages into useful resources. The biogas plants may be taken up by community groups and institutions running Gaushalas like Trusts, Milk Unions/ Cooperatives, NGOs and FPOs having cattle populations inside a single premise in rural areas.

### **Site Selection**

1. The site should be situated within the institution's premise it aims to serve and it should have access to at least 15 cattle within the premise.
2. The site for biogas plant should be preferably at a higher level as compared to the surroundings so that accumulation of water can be avoided.
3. The site should have access to adequate water supply for the biogas plant's operations, including feedstock preparation, cleaning of equipment, and maintenance.
4. Biogas plant should be installed in the open space to have the full benefit of sunlight.

### **O&M**

1. Biogas infrastructure should be owned, operated, and managed by the Institution itself.
2. The slurry left out from the digester is very rich in Nitrogen, and Phosphorus and is a good fertilizer for crops. Therefore, the slurry may be used directly in the fields, or it may be used after drying by converting into bio-fertilizers/ organic manure.






