

**PROCEEDING OF THE TENDER COMMITTEE MEETING HELD ON DATED 23.08.2023 AND 02.09.2023 FOR SELECTION OF HUMAN RESOURCE SERVICE PROVIDER AGENCY (HRSPA) FOR SUPPLY OF NREGA ASST., ACP, TECHNICAL EXPERT, SOCIAL AUDIT ASSISTANT AND GRIEVANCE REDERESSAL ASSISTANT FOR THE OFFICE OF 07 BLOCKS OF THE DISTRICT, ZILLAPARISHAD, GAJAPATI, HORTICULTURE, DFO, ITDA, AND WATERSHED OFFICE OF GAJAPATI IN THE CONFERENCE HALL OF ZILLAPARISHED GAJAPATI.**

In order to selection of Human Resource Service Provider Agency (HRSPA) for supply of Manpower to different Offices of the District under Scheme like, MGNREGS and post like NREGS Asst., ACP, Technical Expert, Social Audit Asst. and Grievance Redressed Asst. in the Office of Blocks, Zilla Parishad, ITDA, DFO, Horticulture and Watershed of the District a Tender Call Notice was published vide Tender Notice No. 2332, dated 03.08.2023. The Deputy Director, I&PR Department, Govt. of Odisha, Bhubaneswar was requested to publish the Advertisement in two widely circulated News Paper One Odia daily and One English daily). Accordingly it was published in daily News Paper. The New India Express dated 08.08.2023 and an Odia daily.

Further, DIO, NIC, Gajapati was also requested vide Memo No. 2333, dated 05.08.2023 for webhoist in the District Website [www.gajapati.nic.in](http://www.gajapati.nic.in) and requested all the District Level Officers vide Memo No. 2334, dated 05.08.2023 i.e. all BDOs/all Tahasildars/all EOs of ULB to publish the Advertisement on their Notice Board. As per the Advertisement the last of date of receipt of Sealed Bid was 22.08.2023 up to 01 P.M. and date of opening of Technical Bid was on 23.08.2023 at 10.30 AM. As the Inauguration of "MO BUS STAND" programme was there on 23.08.2023, hence the date of opening of Financial Bid was scheduled on 02.09.2023 at 10.30 AM.

A Tender Committee was constituted for the purpose under the Chairmanship of CDO-cum-EO, ZP, Gajapati consisting the following members:

As per the Tender clause the Technical Bid Papers were opened first on dated 23.08.2023 at 10.30 AM in the ZP, Conference Hall, Gajapati after the welcome address by the CDO-cum- EO, ZP, Gajapati to all the members and authorized representatives of the tenderer. The list of the Members, Bidders / Authorized representatives is at **Annexure- A**. It was found that 14 (Fourteen) Nos. of Tenders were received through Registered/Speed Post from different Human Recourse Service Provider Agencies. The Committee opened the Technical Bid in presence of the Bidders and Tender Papers were verified thoroughly by the committee with reference to the terms and condition of the tender (i.e. technical requirement for bidding for providing manpower service). It was found that out of 14 Nos. (Fourteen) of HRPSA agencies two agencies i.e.1) M/S ASMACS who had not submitted IT for last three years, 2) M/S Lakheswar Agency who had not submitted Audit Report for FY 2022-2023 were disqualified in the Technical Bid. Similarly, it is found during verification that 04 (Four) Nos. agencies were found Black listed such as i.e. 1) Group No. 5 Security Service has been Black listed by CDMO, Sambalpur vide his letter No. 96, dated 09.01.2018, 2) M/S L& K Service has been Black listed by DFO, Dhenkanal vide his letter No. 3856, dated 08.06.2021, 3) Summit Security Service has been Black listed by CDMO & PHO, Mayurbhanj vide his letter No. 3750, dated 31.08.2019 and 4) M/S Bharati Security Service has been Black listed by Divisional Labour Commissioner Kalahandi vide his letter No. 1804, dated 14.12.2018.

Hence, the rest 08 Nos. of agencies who were found to have qualified in the Technical Bid are as follows:

1. M/S RR Enterprises
2. M/S Biraja Security Service

3. PRATYUSH
4. M/S Neta Security Services Private Limited
5. All Services Global
6. Maharaja Infotech
7. EPSS Overseas
8. Allian Security and Intelligence Security

The evaluation details of Technical Bid are placed in separate sheet at **Annexure- B**. The Financial Bid of above mentioned 08 Nos Bidders were opened by the Tender Committee on date 02.09.2023 at 10.30 AM in the Conference Hall of ZP, Gajapati under the Chairmanship of CDO-cum-EO, ZP, Gajapati. After verification of the Financial Bid Papers the details of Service charges and other statutory dues quoted by the Bidders in Financial Bid is placed at **Annexure- C**. During scrutiny of the Financial Bid papers it was found that agencies such as 1) M/S Biraja Security Service, 2) EPSS Overseas, 3) Allin Security and Intelligence Service had quoted the Service Charge more than the prescribed rate i.e. 3.85%. Hence, these agencies were also rejected.

Similarly, out of the rest 05 (Five) Nos. of agencies Two agencies such 1) M/S RR Enterprises and 2) Maharaja Infotech had quoted the GST less than the prescribed rate i.e. 18% hence, these two agencies are also rejected. After rejection of the above mentioned agencies due to the technical or the financial grounds finally the following 03 (Three) agencies found to have qualified both in Technical and Financial Bid fulfilling all necessary terms and condition as per Tender notification.



In case the agency selected as L-1 is failed to supply the Manpower and executing/depositing the relevant dues as per the terms and condition of the tender notification the successive agencies as L-2 / L-3 may be awarded accordingly.

The meeting ended with vote of thanks to the Chair.






