In pursuance to letter No.23123/PR&DW dtd.07.10.2023 of Government in PR & DW Department, Odisha, applications are invited **in the prescribed format enclosed** from the interested retired Government Engineering Personnel (JEs/AEs) below the age of 65 years and having good service records and physically fit for engagement as O.S.D. on contractual basis against vacant posts in Gajapati district under PR Cadre of PR&DW Deptt. for a period of one year from the date of his/her joining. The details of the application format, criteria, remuneration, terms & conditions of the posts are mentioned as detailed below. The filled in application should be addressed to the **CDO-Cum-Executive Officer, Zilla Parishad, Gajapati** and should reach on or before **30.11.2023**. Application(s) received thereafter shall not be entertained.

TERMS & CNDITIONS:

- The contractual engagement shall be made initially for a period of 1 year from the date of his/her joining and can be extended yearly basis upto the age of 65 years subject to satisfactory performance or appointment of regular JEs/AEs whichever is earlier.
- The appointee has to discharge his/her duties in such a manner, as may be prescribed by the concerned controlling authority from time to time under whom he/she will be posted.
- The retired Govt. servant against whom a Vigilance Case or Departmental Proceeding or criminal prosecution is contemplated or pending or who has been penalized for misconduct during the period up to five years preceding his/her retirement, or is a member of a political party will not be considered for re-engagement.
- Candidates having computer knowledge (MS-Word, MS-Excel) will be given preference.


- The selection will be governed by the procedure and rule laid down in G.A. Department Resolution No.23750/GAD, dated 27.08.2014.
- The period of contractual engagement shall not be counted as Government Service for the purpose of pension and any other retirement benefits.
- Consolidated remuneration of the contractual employee shall be fixed to Rs.20000/- P.M. with additional amount not exceeding Rs.5000/- P.M. towards conveyance allowance / mobile allowance etc.
- The contractual engagement may be terminated at any time by the Collector-Cum-CEO, Zilla Parishad, Gajapati (Appointing Authority) for unsatisfactory performance, on one month notice and in case of any misconduct including misappropriation, negligence or causing loss to Government, without any prior notice. One month notice shall also be mandatory to quit the engagement.
- Eligible & interested candidates may submit their applications in the prescribed proforma with copies of the testimonials in support of their service records **by Registered Post / Speed Post only.**
