
OFFICE ORDER

Sub: Ban on selling and use of polythene and Plaster of Paris.

It has come to the notice of the District Administration that use of Polythene carry bags and making and selling of idols made of Plaster of Paris are being carried out in Gajapati district despite of discouraging among Public for the same. As monsoon has onset and the festive seasons are coming ahead and as such it is high time to stop such use of Polythene to prevent logging of drains, water bodies and Plaster of Paris to save environment as well as public from health hazard.

Therefore, in exercise of powers conferred on me under Section 152(1) of the Bharatiya Nagarika Surakhya Samhita, 2023, I do hereby order that selling and use of Polythene and materials made of Plaster of Paris are banned in Gajapati district for 90 (Ninety) days from the date of issue of this order. Any deviation of this order shall be treated as public nuisance and the person/ Agency responsible shall be proceeded against under the Bharatiya Nagarika Surakhya Samhita, 2023.

This order will come into force with immediate effect.




