The Travel Agencies shall submit their quotation/tender to spare their Vehicles which should be reached the undersigned on or before **25.09.24 by 1 PM** by Speed / Regd. Post / By hand and the same will be opened on **dt. 25.09.2024 by 4.00 P.M** in the presence of the Tenderers' or their authorised Agents. The under signed reserves the right to reject all or any of the quotation without assigning any reason.

- 1) The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. of Odisha and Andra Pradesh, which are mandatory for playing of Vehicle.
- 2) The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle.
- 3) The Driver should be well behaved, gentle and obedient in nature.
- 4) A sum of Rs.5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn on favour of the **Deputy Director(Planning & Statistics), DPMU, Gajapati** and submitted along with the tender as security deposit. After Completion of tender process, the amount will be refunded to unsuccessful bidders.
- 5) The monthly rate of hire charge be quoted separately in the general bid information (**excluding fuel and lubricants**)
- 6) The Vehicle must achieve **fuel efficiency (by Diesel) of 10 Kms per litre.**
- 7) The details of the make and year of manufacture of the vehicle, registration no., mileage (Kms covered per litre) and name of the Driver with Driving License No. and period of Validity should be specifically indicated.

Annexure-II
TERMS AND CONDITIONS FOR HIRING OF VEHICLES.

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

- 1) The hired vehicles, during period of contract, shall have all necessary valid MV documents such as:- Valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid Contract Carriage Permit, Proof of up to date tax payment etc. and D.L. of the Driver available all the times. The department/Office hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicles or loss of life/injury made to any person or damages to any property on account of use of hired vehicle any manner whatsoever. The owner of the vehicle shall be responsible for all such litigation.
- 2) The hire charges to be paid for monthly basis is final but does not include cost of diesel, which is to be paid separately basing on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating oil of Engine, Gear Box & differential Coolant, Tyres & Tubes Battery etc. will be borne by the bidder.
- 3) It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
- 4) In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle.
- 5) In case of the Vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
- 6) The vehicles shall report for duty **for whole month/ minimum of 25** days in a month. In case of nonavailability of vehicle penalty as decided by finance department shall be imposed in addition to deduction at pro-rata basis for absent from duty.
- 7) In case of emergency, the driver will have to report for duty as per the requirement of the authority of DPMU, Gajapati No extra payment shall be demanded.
- 8) Monthly hire charges and reimbursements towards cost of diesel (as per actual) and lubricants that the fuel is to be borne by the District Planning & Monitoring Unit, Gajapati at mileage rate of 10 Kms per litre and lubricants will be issued as approved by Finance Department Govt. Of Orissa from time to time. That as per F.D. Circular No. 34085/F dt. 29.2.2012(as per Govt. Norms)of selected bidder will be paid in every succeeding month as far as possible within fifteen days of them submission of bills by the service provider and no advance payment will be made further payment will be made after receipt of fund from Government.
- 9) The vehicle shall not more than 3(three) years old from the initial registration and also in good running condition during the period of contract.
- 10) If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement of the Vehicle.
- 11) In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
- 12) If bidder violates any of the terms of contract, Government shall forfeit the entire amount of security deposit.
- 13) The hiring charges of the vehicle per month shall not exceed Rs.31000/-(Thirty-one thousand) only.
