E.M.D required against each work should be enclosed along with the tender duly pledged in favour of B.D.O, Rayagada, Gajapati in shape of Postal SB/TD/NSC/KVP/Deposit receipt of scheduled bank etc. The cost of tender paper for each work as noted above should be deposited along with application by DD/ Pay Order in favour of BDO, Rayagada (not refundable). The tender paper will be available for sale during office hours (10.00 AM to 4.00 PM) on all working days from 04.10.2024 to 22.10.2024 up to 4.00 PM at the office of the B.D.O, Rayagada, Gajapati. The Xerox copy of all valid



contracts License, VAT clearance certificate, PAN card and labour licence duly attested by a Gazetted Officer are to be furnished along with the tender. The tenderers are required to furnish an affidavit about the Authenticity of tender documents along with the tender paper. The tender without the above documents and E.M.D. will be rejected. The tender documents will be received through the registered post with A.D. or through Speed post or by person only. No other mode of receipt of tender document is allowed. The authority will not be responsible for the postal delay. The tender will be opened on the date notified above in presence of tenderers or their authorized agents. The tenderers are to submit the original licence to the tender committee at the time of tender opening for scrutiny. The authority reserves the right to reject any or all tenders without assigning any reason thereof. The decision of the Tender Committee shall be final binding. The successful tenderers are required to submit detail work programme at the time of execution of agreement. The successful tenderers are required to draw F2 Agreement .

Condition-1: The Engineering contractors seeking exemption of EMD have to produce their original license at the time of opening of tender for entering of EMD exemption since they can be awarded maximum in three works in a financial year with such exemption.

Condition-2: As per amendment to para 3.5.5 (V) of note:2 of OPWD code volume-I by modification. Official memorandum No. 5288, dated 04.05.2016 of works Department- Additional performance security shall be deposited by the successful bidder when the bid amount is unbalanced that is less than the estimated cost put to tender, in such an event, the successful bidder who have quoted less bid price/rates than the estimated cost put to tender, shall have to furnish the exact amount of difference cost i.e. estimated cost put to tender (-) the quoted , as Addl. Performance Security in shape of Post office, Bank Account (NSC/POTD account/KVP/Deposit receipt of schedule Bank ) duly pledged in favour of B.D.O., Rayagada.

Condition-3: Excess cost of tender then the estimated cost will not be entertained.




