1. The tenderer shall have valid OGST registration to participate in the tendering.
2. The tenderer, participating in the bidding process under the jurisdiction of Municipal corporations, shall be registered on GeM platform.
3. The vehicle must be road worthy condition, shall not be more than 3(Three) years old from the date of initial registration and must have valid Registration Certificate, Insurance certificate, Fitness Certificate, Valid Contract Carriage Permit(State of Odisha & Andhra), Proof of up to date tax payment, PAN Card etc. which are mandatory for plying of vehicle.
4. The driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport/passenger vehicle.
5. The driver should be well behaved, gentle and obedient in nature.
6. A sum of Rs.12,000/-(Rupees twelve thousand) only shall be deposited by the intending bidder in shape of Account Payee Bank draft drawn in favour of the District Project Coordinator, Samagra Shiksha, Gajapati, payable at Parlakhemundi and submitted along with the tender as security Deposit, after completion of the tender process, the amount will be refunded to unsuccessful bidder.

TERMS & CONDITIONS

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

1. The hired vehicles, during period of contract, shall have all necessary valid MV documents such as valid Registration Certificate, Insurance Certificate Pollution Certificate, Fitness Certificate, valid Contract Carriage Permit (State of Odisha and Andhra), proof of up to date tax payment etc. and D.L of the driver available all the times. The undersigned shall not be responsible for any damage/loss caused to hired vehicles or losses of life/injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.

2. The undersigned hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicles or loss of life/injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigations.

3. The hire charges to be paid for monthly basis is final but does not include cost of fuel which is to be paid separately basing on actual consumption and lubricants as per existing Govt. norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating oil of Engine, Gear Box & differential Coolant, Tyres & Tubes, Battery etc. will be borne by the owner.

4. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner. The driver of the vehicle must have valid Driving License for driving light transport passenger vehicle, & should have sufficient experiences in driving transport passenger vehicles. The driver should be well behaved, gentle & obedient in nature.

5. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/bidder.

6. In case of the vehicle do not report regularly, the authority will be at liberty to terminate the agreement without prior notice.

7. The vehicle shall report for duty for minimum of 25 days in a month.
8. In case of emergency, the driver will have to report duty as per the requirement. No extra payment shall be demanded.
9. Monthly hire charges and reimbursement towards cost of fuel (as per actual) and Lubricants (as per Govt. Norms) of selected bidder will be paid in every succeeding month, as per as possible within fifteen days of the submission of bills no advance payment will be made.
10. The vehicle shall not be more than three year old from the initial registration and also in good running condition the period of contract.
11. If the services are found to be unsatisfactory, the undersigned has right to issue notice for terminate the agreement.
12. If the service provider intendeds to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal and termination of agreement.
13. All disputes relating to the contract in subject to the pecuniary jurisdiction of the court at Gajapati.
14. If any bidder violates any of the terms and contract, Government shall be forfeit the entire amount of security deposit.
