TERM & CONDITION

1. The Internet service provider (ISP) must be registered in India as Limited company/Sole proprietorship under relevant acts .
2. Installation should be completed within 10 days after issuing of work order.
3. The Contract will have a validity of one year from the date of installation & subscription.
4. ISPs should have local office in Odisha and near by service centre at Paralakhemundi / Berhampur.
5. The service shall be provided 24x7 days in a week. The ISP should have own manpower & technical team for support in Paralakhemundi for any downtime.
6. The response time for attending the fault will be one hour after they are reported. The ISP will rectify the faults within 12hrs, failing which the ISP will make temporary arrangement.
7. Minimum 8 nos of IP to be provided for internet service.
8. Bidders / ISPs have to submit last 3 years IT returns.
9. Bidders / ISPs to arrange repair and maintenance for above contract period.
10. The rate quoted for complete installation of internet should be competitive and all detailed component, if any required, to be mentioned clearly with specific rates and GST there on.
11. If the service will be found unsatisfactory, the contract of ISP will be terminated and same service will be provided to second deserved ISP.
