ELIGIBILITY CRITERIA OF THE SUPPLIER (SELF ATTESTED DOCUMENTS REQUIRED TO BE SUBMITTED):

1. The supplier should be able to supply **04 weeks' old unsexed indigenous variety poultry / Sourangi breed poultry bird** as approved by Gol only for backyard poultry rearing & suitable for PVTG area.
2. The supplier must have supplied at least 50,000 nos. of birds in total during period of FY 2021-22 & 2022-23, 2023-24 & 2024-25 under different livelihood schemes of Govt. / NGOs/ Private farms/Agencies. He has to produce Credit Invoice raised by the bidder indicating nos. of birds supplied duly signed by the Competent Authority.
3. The supplier should belong to State of Odisha or have its registered/branch office in Odisha. For that the bidder has to submit the rent agreement/electricity bill/phone bill/declaration in form of an affidavit etc. The supplier must have valid OGST Registration Certificate with up-to-date filing of returns and submit copy of PAN Card & Copy of IT Return for financial year FY 2023-24 & 2024-25.
4. The authorized supplier must produce certificate from original breeders regarding procurement of eggs/day old chicks mentioning the breed.
5. **Subletting rearing process by the supplier is strictly prohibited.**
6. The monthly capacity of the original breeders farm from which the supplier received the hatching eggs\ day old chicks must be produced by the supplier duly certified by the original breeder.
7. If the supplier has its own / lease hatchery unit, then he has to produce the certificate from local Veterinary Officer mentioning per month hatching capacity along with production of authentic documents.
8. The supplier has to produce the details of the rearing units (i.e. its capacity, location, ownership etc). He has to produce the documents/ certificate from local Veterinarian regarding this.
9. In case of expansion or closure of any rearing unit during the period of contract, due permission from CDVO concern must be obtained.
10. Declaration in shape of an affidavit duly sworn in Rs.100/- Non-Judicial Stamp Paper (on the stamp paper of Rs. 100/- value in shape of affidavit from notary) to the effect of the following:
 - a. that the firm/organisation has not been debarred /black listed or derecognised by any State Govt./Central Govt.
 - b. that the firm/organisation/bidders/suppliers must be able to supply minimum 15,000 nos. of 4 wks old unsexed deshi poultry birds per month (indicating the variety of birds to be supplied) @Rs 72.00/- per chick inclusive of transportation cost up to Panchayat level.
 - c. That the variety of bird(s) supplied by him confirm to the specifications and in the event of any dispute arising out of non adherence to the specifications the supplier shall be responsible.
11. The Supplier must submit three vaccination completion certificate of the birds (i.e. Marek's Disease, F1 Lasota & its booster & IBD) maintained at Chick Rearing Unit up to 28 days along with certificate regarding proper health care management from the local Veterinarian in which CRU is established/ from a registered Veterinarian.
12. **The supplier must be able to supply minimum 15,000 nos. of 4 wks old unsexed indigenous variety poultry birds/ Sourangi breed poultry birds per month @ Rs 72.00/- (Rupees Seventy two only) per chick inclusive of GST & transportation cost up to Panchayat level.**
13. The supplier must have its rearing unit within distance of 50 km from the point of supply. In case of the distance of more than 50 kms between the rearing point and point of supply, the supplier has to take one poultry farm on lease within the distance of 50 kms and keep the birds for minimum 10 days there before supply. The CDVO concern will help/assist the bidder for getting the leased farm. Concerned BVO of that area will supervise/ check the management practices adopted by the bidder.
14. Prior information regarding date of receive/hatching of day old chicks must be given to the BVO concern by the supplier.
15. The supplier must allow the concerned BVO to check farm

management before arrival of the chicks, check the quality and quantity of day old chicks on the day of arrival, mortality, vaccination, sanitation, management practices adopted, and feeding practices from 1st day to 28 days at regular interval. Certificate in this regard may be obtained from the BVO concern and produce the certificate during delivery of the chicks.

16. If required the bidder must allow the concerned BVO to take random a sample of the birds for serum surveillance, feed sample and weight of the birds for verification.
 17. It is the responsibility of the bidder to arrange suitable transportation vehicle for transporting the chicks and disinfect the vehicle before each delivery.
 18. The supplier will be responsible for mortality of birds during transportation.
 19. The supplier will supply healthy, disease free agile active birds at Panchayat level of District.
 20. The minimum body weight at the age of 4 weeks birds should not be less Than 160 gm for indigenous variety bird.
 21. The supplier must supply /replace the grade out / dead birds at his own cost within 15 days of Supply and complete the Supply of full allotted stock at respective GP level.
 22. The supplier must allow the BVO concern for random checking of the body weight of chicks on the day of delivery.
 23. The supplier should provide Layer starter/grower feed to the Birds. Broiler pre starter feed should be avoided.
 24. The Supplier must not have been barred or blacklisted by any State / Central Government Departments / Govt. Agencies or any PSUs **(An Affidavit to this effect shall be furnished)**.
 25. The Supplier should not have indulged in any criminal offence (An Affidavit to this effect shall be furnished).
 26. The Supplier shall deposit an amount of **Rs. 500/- (Rupees Five Hundred only)** toward cost of BID processing fee (non-refundable) **in shape of Account payee demand draft/ online transfer.**
 27. **An amount of Rs.50,000/- (Rupees Fifty thousand) towards EMD/BID security through Account payee demand draft drawn in favour of the Chief District Veterinary Officer, Gajapati payable at SBI, Main branch, Paralakhemundi details of which as mentioned below need to be submitted along with the bid documents. The BD form should have validity of at least 45 days beyond the BID Validity period. The bid security will be returned to unsuccessful bidders without interest. The BID security of successful bidders will be adjusted during final payment of the dues. EMD may be forfeited if they withdraw or modified their bids / violet the terms & conditions of EOI.**

 29. If any information or documents furnished by the bidder found to be misleading/incorrect at any stage, their Bid will be rejected.
 30. The quoted rates should be final and shall not be subject to any escalation during the validity of the bid.
 31. All legal disputes, if any relating to purchase etc. are subject jurisdiction in the courts of law situated at Gajapati,Paralakhemundi or Hon`ble High Court of Odisha.
 32. If the selected and approved bidder fails to supply the birds within the stipulated period the Bid Inviting authority reserves the right to place the order to the next eligible bidder,

33. The Payment to the Supplier on the assignment will be made by assigning authority after successful completion of the assignment along with the GST bill.

The authority reserves the right to accept /reject all the bids or any part of it without assigning any reason there of.
