**TERMS AND CONDITIONS OF TENDER FOR TENT & ALLIED WORKS FOR
DISTRICT LEVEL WORKSHOP ON LAKHPATI DIDI, GAJAPATI-2025**

Date of Event: 11.03.2025 (One Day)

1. Sealed tenders are invited from reputed firms, decorators, tent houses and caterers having the work experience of exhibition work and catering in Gajapati District for at least 03 (Three) years. The firm should have the experience of taking the exhibition work of worth Rs. 10,00,000 /- (Rupees Ten Lakhs) only in a single work order.
2. The bidder has to pay of Rs. 1,000/- (Rupees One Thousand) only towards cost of tender paper "ODISHA LIVELIHOODS MISSION, NRLM, Gajapati" payable at Gajapati, which is non-refundable.
3. The bidders should have registered his firm under GST, PAN, FSSAI (for food supply), & also up-to date deposit of GST with latest Deposit Challan (Oct- 2024 & December-2024 Quarter).
4. **The rate offered by the firm shall be including GST as applicable.**
5. **TDS applicable will be deducted from the bill amount submitted and will be deposited under concerned head of account.**
6. The authority is not bound to accept the lowest tender and reserves the right to inspect / verify the stock of materials required for this work, in Go-down of bidders by nominating a Committee to ascertain the credibility of the firm. Further the undersigned reserves the right to reject any or all tenders without assigning any reasons thereof.
7. **The bidder shall quote their price for all the items without leaving blank. If found so, the bid will be treated as non-responsive and rejected.**
8. **The Envelop of the Tender should super scribe "TENDER DOCUMENT FOR TENT & ALLIED WORKS OF DISTRICT LEVEL WORKSHOP ON LAKHPATI DIDI, GAJAPATI".**
9. The bidder has to quote the rate as per the given format.
10. The bidder or the representative of the bidder should attend the opening event of the tender with all original documents/papers for verification, if required.
11. **The duration of the workshop will be for 1 day as per the details given below. All the desired works should be completed at least one day before the scheduled inauguration date and time of the workshop and should hand over all the works as per specification, to the in-charge of workshop.**
12. The contractor should be prepared to provide additional materials in case of requirement at the market price for the items not mentioned in the tender.



13. For convenience and effective delivery, the tender is to be treated as a package of services. Evaluation of the competitive bidding price will be made taking into account the total amount calculated on the entire items.
14. Bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price shall be awarded the contract. The quantities of Lunch may increase or decrease with minimum 15% looking to the attendance of participants.
15. The firm shall not use Child Labour and any prohibited items like Animal Skin & Hair, Sea Shell & Perls in the tentage work, which may attract penal action under relevant law.
16. The bidder has to treat the materials to be used in Tentage work (like - Cloths), with Fire Repellant Chemicals. This work has to be certified by the concerned district fire officer.
17. It shall be the responsibility of the service provider/contractors to obtain requisite permission for electricity connection / fire services for the workshop period from statutory bodies. The bidder has to supply the fire protection equipment like extinguisher as per the requirement
18. In regard to electrical fittings etc. the contractor shall have to engage qualified licensed electrician/contractor entitled to erect, handle and maintain high tension supply line and its up keep and maintenance. The contractor shall have to engage qualified licensed electrician/contractor entitled to erect, handle and maintain high tension supply line and its up keep and maintenance.
19. The bidder should submit a proof of certification of incorporation /Registration of the Agency.
20. The bidder should not have been black listed by Central/State Govt. Institutions for any means of non-obligation – The bidder should submit a self-declaration on this.
21. Average Annual Turnover should be at least Rs. 15 Lakhs in last three year as on 31.03.2024.
22. On completion of the workshop, the contractor shall have to take away all the materials within three days & vacate the place with the same condition while occupying the ground.
23. The final payment will be made on the basis of the actual work done and Work Assessment Report in the specified format by the workshop-in-charge. The contractor shall not use any additional materials other than the work specified in the work order the prior permission of the workshop-in-charge. In case of any additional requirement, the contractor has to take the prior written permission from the workshop-in-charge.
24. Bidder will be responsible for up keep and maintenance of the entire work done by him till the closing of the workshop. DMMU, OLM, Gajapati will not be responsible for any breakage, damage, fire, theft etc. of his materials and insurance if any.
25. No part of the contract will be sub-let without the prior written permission of the workshop-in-charge.
26. The bidder is to submit self attested photocopies of the required documents with duly filled in tender paper.
27. The Bidder has to handed over the complete structure along with all electrification to the undersigned latest by 10th March-2025 afternoon positively.

28. Payment shall be made after delivery of the services (as mentioned in the tender document and work order) through e-Transfer (EFMAS) after submission of the bills, vouchers & bank A/C Photocopy.
29. Any legal dispute arising out of this is subject to Jajpur district jurisdiction only.
30. The Agency/Bidder shall not be black listed by any Govt. Organization. If found later on, the action deemed to fit will be initiated against the agency/bidder as per the law.
31. **The bidder has to submit the technical bid and financial bid in two separate envelopes. The technical bid will be evaluated first. The financial bid will be opened only of the bidders who have qualified the technical bid.**
32. The bidder is to submit self attested photocopies of the required documents with duly filled in tender paper. The documents to be submitted by the bidder are:

Work Description

1. Stage with public address system:

One close stage shall be erected and decorated in the District Level Workshop on Lakhpati Didi. The bidder has to quote as a package against the detail specifications given below:

Structure	Iron fabricated structure 40'X20' size & height from ground surface 5' with plywood floor.
Flooring	The entire floor of the stage shall be covered with carpet of fine quality.
Back Drop	Size of the back ground will be 30' (L) & at least 15' (H) with fine cloth masking of the back & Top ceiling of the stage.
Step	Step will be erected in one side of the stage covered with carpet and barricade.
Furniture	12 no. of VIP Chairs with white towels, 4 no. of center Tables, Table Cloth, one speech podium, etc., will be provided on the workshop day.
Flower Decoration	Flower decoration of the centre tables, speech podium and front stage.
Light & Sound	Micro phone with good sound in the Podium and two-three cord less phone and sufficient boxes and mike to be audible for audience of 4000.
Other arrangement	Required nos. of light, fan & cooler for the stage.

2. Participant Sitting Arrangement:

Sitting arrangement for 4000 participants attached with main stage. 4000 Plastic Chairs for participants and 50 chairs for the officials & dignitaries. The roof of the area will be water proof tarpaulin with fine cloth ceiling. Sufficient ceiling fan and stand fan will be fixed in the sitting area. The side of the Audience sitting area will be barricaded with bamboo.

3. Erection of food distribution counter:

10 nos. of food distribution counter will be erected for serving food to the participants. Each stall with minimum size 10'x5' covered with tarpaulin will be erected. Sufficient tables will be arranged for keeping the food items.

4. Generators:

Generator sets (50 KVA) with required fuel shall be provided by the tenderer for the entire workshop period. The tenderer should always be prepared for uninterrupted power supply for the workshop.
