Quotations in sealed cover are invited from the reputed and experienced firms/decorators/tent houses for "Construction of Temporary main stage with replica representing various historical monuments, tribal arts, natural tourist places arts of Gajapati district (As decided by the authority) with centre led display& construction of temporary barricade for stage with supplying of furniture & carpets etc as required for the ensuing Gajapati Utsav - 2025 (For 5 Days) to be held from dt.18.01.2026 to dt.22.01.2026 at Gajapati Stadium, Paralakhemundi.

The offers should accompany with their past experience with photographs/ CD which would be displayed through the power point before the chairman, Gajapati Utsav. The decision of the committee will be binding in case of award of work. Along with the cost the quality /exposures/innovative ideas for main stage backdrop will be taken into consideration in selection of the award of work. However, offers must indicate the cost for each item separately.

The intending persons may inspect the proposed venue prior to submission of their offer.

The selected Firm / Decorators / Tent houses will be required to deposit a security amount of Rs. 25,000/- (Rupees Twenty-five thousand) only in shape of Demand Draft *in favour of the Collector & District Magistrate, Gajapati-cum- Chairman, Gajapati Utshav Committee* before issue of the work order and the same will be refunded with 7 (seven) days of completion of the Utshav and final payment of the work will also be made within a week of completion of the Utshav.

The last date for receipt of offers at office of the Superintending Engineer, Paralakhemundi (R&B) Division is on 09.01.2026 up to 2.00 PM and will be opened on 09.01.2026 at 4.00 PM in presence of members of Stage Committee and participants or their authorized representatives.

The quotations should be accompanied with the Name of the Firm / Decorator / Tent house (2) Name of the proprietor (3) Address with contact number.

CONDITIONS:

1. **Stage Decoration:** This Should have an attractive back ground consisting replica of Gajapati Palace with Photo, B.N. Palace, Temple of Mahendra Giri, Jeerango Buddhist Temple, Old Train Engine, Waterfall of Gandahati, Mankada Diha, Car Festival, Dancing of Tribal Ladies, Church.
2. **One Selfie point with an attractive concept.** The concept has to be prepared in a 3D image format and presented before the Committee for final approval.

All the rates have to be quoted separately and firms who have experience in the organization of such mega functions will be given priority. The entire work has to be completed and handed over to the organizers at least 48 hours before the

inauguration day. The rates should include all taxes and incidental charges. The tender form should be accompanied with a non-refundable Account payee Demand Draft of Rs.2000/- (Rupees Two Thousand) only in favour of the Collector & District Magistrate, Gajapati-cum- Chairman, Gajapati Utshav Committee.

Imp Note:

- The payment will be made to the agency basing on actual quantity of execution of the work as per the requirement of the committee.
- The authority has full rights for change in scope of the arrangements of Gajapati Utsav for any additional item if required beyond the list of the mentioned items in the quotation on demand of the committee during execution of the work. Extra payment will be made accordingly.

The Tender form is obtainable from the office of the Superintending Engineer, Paralakhemundi (R&B) Division on working days from 03.01.2026 at 10.00 AM to 08.01.2026 up to 4.00 PM.
