



Proceedings of the Tender Committee Meeting held on dtd.04.11.2025 & dtd.14.11.2025 at Zilla Parishad Conference Hall, Paralakhemundi, Gajapati for Selection of HRSP for ZP,Gajapati

As per the Tender Call Notice No. 3703 dated 10.10.2025, a Tender Committee Meeting was held under the Chairmanship of CDO-cum-EO, ZP, Gajapati on dtd.04.11.2025 & dtd.14.11.2025 at Zilla Parishad Conference Hall, Paralakhemundi, Gajapati for Selection of HRSP agency for different schemes/section under ZP, Gajapati for opening of the Bid documents in presence of the following members of the committee:

- Addl. EO, Admin, ZP, Gajapati.
- Programme Manager, Finance.
- Programme Manager, Rural Housing.

- Deputy CEO, ORMAS, Gajapati.

In response to Tender call notice No. 3703 dated 10.10.2025, 17nos. of bids were received for opening of the technical bids on dtd.04.11.2025 and due to non-completion of the process again decided to complete the entire process on dtd.14.11.2025: (Attendance at Annexure-I(A)&(B))

On dated 04.11.2025, the tender committee opened the Technical Bids of the above 17 bidders in which only 12 representatives of the participating parties out of the 17 bidders were present (As per annexure-I). During opening of the tender Papers, the committee scrutinized all the tender documents and proposed a new date i.e. on dtd.14.11.2025 for proper verification of all tender documents & for finalization of technical bid.

On dated 14.11.2025, the tender committee meeting was held at 10.00am at Zilla Parishad Conference Hall, Paralakhemundi for final scrutiny of technical bids and the following observations were made: (Annexure-II)

- The bid of Manpool India Pvt. Ltd., was rejected due to non-submission of EMD of Rs. 1,50,000/-, work completion certificate and Affidavit related to blacklisting.
- Techno Facility & Management was also rejected due to non-submission of attested copy of the IT return for the last 3 financial year & work completion certificate.
- M/s. Sumeet Security Services was also rejected as it was barred from participating in similar type of tender due to pending of WP(C) in the court as per his declaration.
- M/s. Surendra Barik Intraservice Pvt. Ltd, Techno Facility and Management Services Pvt. Ltd. was incorporated during 2024 hence rejected due to non-fulfill the criteria for minimum experience.
- As per the bid document terms and conditions, M/s. E1 Security & Services, Herald Manpower & Placement Services, Shree Infotech, All in Security and intelligence service, All Service Global, M/s. Biraja Security Service and Bharat Security Service were also rejected due to partnership or proprietorship firm which was not cited in the tender call notice.
- Out of 17nos. of bids only 7nos.of bids were found to be eligible as mentioned in Annexure-II.
- in view of above, the committee recommended to cancel the tender call notice issued vide No.3703 dated 10.10.2025 as per DTCN No.3697 dtd.10.10.2025 and due to following reasons:
 - a. **Lack of Adequate Competition:**
 - Only 7 out of 17 bids found eligible technically, which is <50% success rate.
 - This indicates restrictive or ambiguous eligibility conditions, violating OGFR intent of wider, healthy competition and fair participation.



b. Restrictive/Defective Eligibility Criteria:

- Tender terms allowed only Company/Society registration, excluding Partnership/Proprietorship firms.
- OGFR promotes maximum eligible participation unless lawfully restricted, hence the criteria are defective and requires rectification before issue of tender call notice in future.

c. Disproportionate Disqualification:

- Maximum 10nos.of bidders were rejected on documentation/ registration grounds.

d. Need for Course Correction:

- To realign with OGFR principles, the tender must be redesigned to include all eligible firms, viz: Company/Society/Partnership/Proprietorship Firms and requirement of eligible bid documents.
- Here the Committee unanimously decided to **cancel** the Tender Process in order to provide sufficient opportunities to the participants in the interest of public at large and refund the EMD at present as per provision to uphold fairness.

The meeting ended with vote of thanks to the Chair and all the members.
