**CORRIGENDUM.**

A. At page number 6 of the tender document, point no. 2, section-2, "Information to the Bidders", "Pre-qualification/Eligibility Criteria".

Eligibility Criteria: The agency / bidder should have total annual turnover of more than Rs. 1.0 (One Crore) from Advertisement & Publicity or Event Management services during the last 4 financial years (2021-22, 2022-23, 2023-24 and 2024-25).	Eligibility Criteria: The agency / bidder should have a cumulative turnover of more than Rs. 1.0 (One Crore) from Advertisement & Publicity or Event Management services during the last four financial years i.e. 2021-22, 2022-23, 2023-24 and 2024-25.
Supporting Documents Required: Copies of audited balance sheet/ Income Expenditure Statement for last four financial years certifying that the firm had an average annual turnover more than Rs. 1.0 (One Crore) during the four financial years (2021-22, 2022-23, 2023-24, 2024-25). Certificate from Chartered Accountant to be submitted.	Supporting Documents Required: Copies of audited balance sheet/ Income Expenditure Statement for last four financial years certifying that the firm had a cumulative turnover more than Rs. 1.0 (One Crore) during the four financial years (2021-22, 2022-23, 2023-24, 2024-25). Certificate from Chartered Accountant to be submitted.

B. At page number 9 of the tender document, section-B, Sl. No. 1, "Turnover", "Technical Evaluation Criteria".

Existing Provision	Revised Provision
The bidder must have total turnover of more than Rs.1.0 Crores from event management business only from the financial year 2021-22 to 2024-25.	The bidder must have a cumulative turnover of more than Rs. 1.00 Crore (Rupees One Crore only) from Event Management business during the financial years 2021-22, 2022-23, 2023-24 and 2024-25.

All other terms and conditions of the Tender Call Notice remain unchanged.
